The principle of good faith permeates international arbitration. Yet, its existence, nature and extent is often assumed and rarely demonstrated by writers and tribunals. Is good faith an organising principle by which all other principles can be located or dependent on custom, practice, law, seat and tribunal? Join us as we explore the origins of the principle and its effective practical application in international arbitration; from the positive duty to arbitrate, to negotiations during arbitration, to estoppel, waiver and issue preclusion.
