About This Talk

This seminar will explore some of the issues regarding quantification of loss arising at first instance and in the Court of Appeal in "the Asia Star" [2009] SGHC 91.

The session chair will briefly review the recent Singapore decisions on quantification of damages after Ms Andrews' presentation.

1. In particular: measuring damages for non-shipment:
 - What is the correct approach to market valuation of the goods?
 - CIF price, spot price or forward price?
 - Which date or dates are relevant?
 - Is there a difference of approach in shipping and sale of goods cases and if so, is it justified?
2. The duty to mitigate – does the innocent party still have an unfettered choice provided he acts reasonably?
3. The relationship between causation and mitigation.

Geraldine Andrews QC



Geraldine Andrews studied at King's College London, where she attained a first class honours LLB and an LLM. She was called to the Bar by Gray's Inn in 1981 and joined Essex Court Chambers on completing her pupillage in 1983. She became a Queen's Counsel in 2001.

She has a broad based practice in international and commercial law in line with Chambers' profile, appearing as counsel in many shipping, commodities, reinsurance and banking cases in court and in international arbitrations. She was co-author of the first edition of Gee on Mareva injunctions, and is co-author with Richard Millett of "The Law of Guarantees", the 6th edition of which is currently in preparation.

She has been advising law firms and clients in Singapore for over 25 years, assisting with complex trials, arbitrations, and appeals to the Singapore Court of Appeal. She sits as a Deputy High Court Judge in England, and is regularly appointed as an arbitrator in international arbitrations (including by the ICC and LCIA). She is on the panel of SIAC and an associate member of the LMAA.



THE MARITIME LAW ASSOCIATION OF SINGAPORE

The Maritime Law Association of Singapore (MLAS) aims to promote the study and advancement of maritime law and its administration in Singapore, and to promote and consider with other associations proposals for the unification of maritime law and practice of different nations.

The MLAS is a member organization of the Comité Maritime International (CMI) a non-governmental international organization devoted to the same object of the unification of maritime law and is the only organization in Singapore entitled to attend the International Conferences of the CMI. At these international conferences, discussions take place between delegations sent by the maritime law associations around the world with the object of arriving at conclusions on issues of maritime law of the day for transmission to the governments of the association's country or to international organizations such as the United Nations and the International Maritime Organisations. As a result, the CMI plays an active role in the initiation, promotion and review of international maritime conventions and model laws. The CMI is also the keeper of the York-Antwerp Rules on general average. At the recent International Conference of the CMI in Vancouver, discussions were undertaken on topics such as a draft instrument/convention on carriage of goods wholly or partly by sea, amendments to the York-Antwerp Rules, international law on places of refuge for ships in distress, marine insurance, and the review of oil pollution conventions.

Members of the MLAS may participate in the development of maritime law, for example, by making their personal views or the view of their industry sector known to the MLAS, who will endeavour to present a balanced view of maritime interests in Singapore to the CMI and other associations concerned with the making or development of maritime law. The MLAS also organizes talks and seminars from time to time to promote discussion of issues of maritime law.

Any person above 21 years of age and resident in Singapore interested in the objects of the MLAS (including non-lawyers in the shipping industry) and all advocates and solicitors who hold a practicing certificate in Singapore are eligible for membership in the MLAS.
