BACKGROUND OF PRESENTATION

- ✘ In September 2013, the Full Court of Appeal of the Federal Court of Australia gave decisions in two cases, both of which relate to foreign maritime arbitral awards and reflect a pro-enforcement attitude to such awards , one relating to voyage charterparties and contracts of affreightment and the other relating to the role of enforcement courts of New York Convention countries, having regard to the conclusions of the court of the seat of the arbitration.
- ✘ Peter will review each decision and their particular relevance to those interests seeking favourable jurisdictions in which to enforce foreign arbitral awards.

Peter has acted as an arbitrator in ad hoc and institutional arbitrations, including those conducted under the auspices of ACICA, the International Chamber of Commerce (ICC), the Hong Kong International Arbitration Centre (HKIAC), the London Maritime Arbitrators Association (LMAA) and the Singapore International Arbitration Centre (SIAC). He is an arbitration panel member of arbitration bodies in Australia, China, Hong Kong and Singapore.

He lectures in international commercial arbitration and maritime law at universities in Australia and France.

Prior to 2010 Peter practised as a dispute resolution lawyer for over 30 years in particular in trade and transport disputes, being admitted in Australia and England and Wales.
