Martin Juste is currently working as the legal counsel for Siemens' Wind Power business in APAC in respects to service of on- and offshore wind farms.

Before moving to Singapore Martin Juste was involved in offshore wind farms in Europe and has been negotiating some of the biggest offshore wind contracts in the world. This includes negotiating the charter parties required to erect and service the wind farm by crew transfer vessels, jack-up vessels, hotel and accommodation vessels and service operation vessels.

Martin Juste is Danish qualified lawyer and is admitted to the Danish Supreme Court. Before joining Siemens Martin Juste has been working in private practice with maritime and transport law. On top of his Master degree in law he has a single subject exam in maritime law and oil and gas law from the recognized Scandinavian Institute of Maritime Law.

Martin Juste also acts as arbitrator in maritime and wind power related disputes.
