# The Lloyd's List Asia Pacific Awards recognise excellence across the range of sectors within the shipping world.

Here are the list of categories:

### **Excellence in Training Award**

This award goes to a company for outstanding commitment in training its employees ashore or at sea or a company or institution that can demonstrate a contribution towards improving training standards in APAC's maritime community. Judges will consider, among other things, examples of investment in new facilities and courses, innovative training solutions and a sustained and effective approach to developing quality staff in the maritime sector. The winner will need to demonstrate why they stand out above all others this year and have set the benchmark for the rest of the industry to aim for.

### Seafarer of the Year

This popular and prestigious award recognises the skill, bravery and professionalism that the industry's seafarers demonstrate daily. We are looking for nominations of crew of all ranks who have shown leadership, courage, seamanship and vision while at sea over the past 12 months. Judges will welcome nominations from individuals or shipping companies putting forward any member of the crew, from ratings to masters whom they believe have exemplified the unique characteristics of seafarers.

**Logistics Award**

The award will be given to the logistics or shipping company that has best worked with shippers not only to provide ocean transportation but a total logistics package with a full end-to-end supply chain management solution across both sea and land within APAC and destinations outside the region. Entrants should demonstrate their particular application of expertise to the Asia-Pacific region and how services have benefitted local customers in the region.

### Terminal Operator of the Year

This award recognises the company or port authority that has maintained the highest standards of operational efficiency and customer service throughout the year. This award is open to individual port or terminal operators as well as larger group operations. Our judges look at quality and performance improvement, not scale. Consideration will be given to tangible examples of innovation, improved efficiency, profitability or successful investment in port operations over the year. Judges will also be looking for evidence of a sustained commitment to customer service, cost and operational efficiency as well as an outstanding safety and environmental record.

### Tanker Operator of the Year

The winner of this award will be a company that has shone brightly throughout the year and can demonstrate first class financial and operational performance. Judges will look for the operator, whether in crude or product or chemical trades, that has led the way by demonstrating a level of excellence that goes well beyond the norm. Submissions may be from companies that have shown a unique and different approach to the sector, leadership in sustainability or business performance or have shown the strength to bring change in the industry.

### The ClassNK Dry Bulk Operator of the Year Award

### ClassNK

The dry bulk market has had a volatile year. This award recognises the operator or owner that has demonstrated the best judgment and strength amidst the volatility. Judges will look for the business that stands out from the crowd. It may be a company that has remained strong, consolidated and/or demonstrated a unique resilience to market difficulties through best of class strategy. The winning dry bulk operator will demonstrate in the entry that, during the previous year, it has maintained first class safety levels, best operational efficiency and consistent performance.

### Safer, Cleaner Seas Award

This environmental award honours the institution, company or individual within the region to have done the most to reduce pollution of the environment from maritime sources. The contribution could include, but is not restricted to, ship design and operation, port operations, company-wide environmental policy, or successful policy effort on the part of a public official with maritime responsibility. Judges will be looking for tangible metrics by which success can be measured.

### The i-Law Maritime Law Award



This award celebrates the very best in the legal profession and will go to the individual lawyer or firm offering legal services that has offered the best service to the maritime industry over the past 12 months. Judges will look for exemplary expertise and commitment to the shipping industry as well as clear examples of innovation through which lawyers have played a crucial role in notable cases, restructuring or dispute resolution.

# The Equatorial Marine Containership operator of the Year Award

This award recognises the containership owner or operator that has demonstrated the best in bold, successful performance in the past twelve months. Judges will require entrants to demonstrate leadership and excellence in the sector and examples of exceptional performance in operational matters such as safety, efficiency and reliability. Entrants will also be required to prove profitability.

This award will go to a young, up-and-coming shipping industry leader who has made an outstanding contribution to the industry. Judges are looking for someone brimming with fresh ideas, new priorities and genuine potential. We encourage entries from all sectors to enter – anyone directly contributing to the shipping industry. Individual entries are welcome, but companies across the industry are encouraged to nominate their best and brightest, supported by examples of why their employee should win. # How do the judges select the winners?

All entries will be assessed by a senior team of Lloyd's List editorial staff before a list of finalists is presented to an independent panel of judges.

This is done to ensure that entry criteria and quality standards are met.

The independent judging panel representing a broad cross-section of the region's shipping community will assess the finalist entries and decide the recipients of all awards, with the exception of: Lifetime Achievement Award, all of which will be decided by the editorial staff of Lloyd's List and Lloyd's List Intelligence. Our distinguished panel will be asked to assess the candidates in each field objectively and to attach most importance to meritorious activity in the last year (defined as 2016-2017, with particular emphasis on the 12-month period up to June 2017).

The criteria for adjudicating the awards differ from award to award, however our judging panel will take into consideration criteria that includes, but is not limited to: business success, quality, growth, exemplary initiative, financial results, share price, investment, integrity, service, safety, environmental record, commercial acumen, technical or operational performance, employment, innovation and good corporate citizenship. The winners (with the exception of the 'Lifetime Achievement Award') will be decided by the panel. The Asia editor, Lloyd's List will chair the panel of judges.

The judges' deliberations and selections, to be decided democratically, are at their own discretion and the panel's decisions are final.

# FAQs

#### Q1. How do I enter?

A. It's very simple. Ensure you have read the entry guidelines and category criteria. Decide which category/ categories you wish to enter, prepare your entry offline. Once you are ready click 'Enter Now' which takes you through the entry stages; follow the on-screen instructions and submit your entry by clicking 'Enter'.

#### Q2. How much does it cost to enter?

A. Entering into the Lloyd's List Asia Pacific Awards is free of charge.

#### Q3. When is the entry deadline?

A. Entries are being accepted up until the 14 July 2017.

# Q5. Can I enter the same submission into more than one category

A. We encourage entries in more than one category per individual or company, where appropriate; please ensure to review the category criteria and tailor your entry accordingly.

# Q7. How will I know whether my submission has been received?

#### Q8. How do the judges select the winners?

A. The judges will convene to discuss all the finalists and will use the published criteria to individually discuss each shortlisted entry to establish the winners. The judging panel comprises independent, senior industry experts, chosen for their knowledge, objectivity and credibility. Judges discuss all categories relevant to their specialist knowledge, expertise and experience, ensuring a considered, educated response to your submission. The chair of the judging panel reserves the right to cast any deciding vote, should the need arise. The judges' decision is final.

# Q9. How will I know if my submission has been successful?

A. All finalists will be notified directly by Lloyd's List in August. Finalists will also be announced on our website lloydslistawards-asia.com. You will be sent a finalist pack giving ideas and tips on how to publicise your success.

#### Q10. What do I get if I win?

A. The Lloyd's List Asia Pacific Awards are highly regarded within the shipping industry, winning an award establishes you as the leader in your field. In addition to your trophy and a certificate of recognition you will receive a winners pack which includes your awards winner logo, photos and ideas on how to publicise your success.
